### TILEGEM SOFTWARE END USER LICENSE AGREEMENT

READ IT CAREFULLY BEFORE COMPLETING THE INSTALLATION PROCESS AND USING THE SOFTWARE. IT PROVIDES A LICENSE TO USE THE SOFTWARE AND CONTAINS WARRANTY INFORMATION AND LIABILITY DISCLAIMERS. BY SELECTING THE "ACCEPT" BUTTON AND/OR INSTALLING AND/OR USING THE SOFTWARE, YOU ARE AGREEING TO BECOME BOUND BY AND ARE BECOMING A PARTY TO THIS AGREEMENT. #### 1. DEFINITIONS

A. "Executable Code" shall refer to portions of the software that contain either compiled binary coded computer instructions or compiled Intermediate Language ("IL") coded computer instructions.

B. "Software" shall refer to all images, Executable Code, Example Demonstrations, and Documentation, or any portion or combination thereof, associated with the TileGem Software.

C. "Agreement" shall refer to this entire "TILEGEM SOFTWARE END USER LICENSE AGREEMENT".

D. "CWD" shall refer to Compass Web Designs LLC of Colorado, USA, including the company itself, members, directors, contributors, all shareholders, board members, managers, and employees.

E. The terms "Software" and "Product" are used interchangeably.

2. LICENSE GRANTS. CWD grants you a non-exclusive license to use the Software according to the conditions specified in this Agreement. All rights not expressly granted herein are reserved by CWD or its successors. You may (a) install the Software on one

or more computers and (b) make one or more copies of the Software in machine readable form, solely for back-up purposes and not for commercial purposes, provided that you reproduce all proprietary notices on the copy.

3. LICENSE RESTRICTIONS. Your license to use the Software and any information (“Content”) found on the Software is subject to the following restrictions and prohibitions on use: (a) You may not reverse engineer, decompile, or disassemble the Software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation; (b) You may not sell, rent, lease, or sublicense the Software; (c) You may not modify the Software or create derivative works based upon the Software; (d) You may not remove, change or obscure any copyright notice or other proprietary notices, trademark, logo, labels or marks found on the Software or Content; (e) You may not use the Software to develop any software or other technology having the same primary function as the Software, including but not limited to using the Software in any development or test procedure that seeks to develop like software or other technology; (f) You may not use the Software or Content to develop, or as a component of, any website or similar resource that is offered for commercial distribution of any kind; (g) You may not create compilations or derivative works of any Content found on the Software; (g) You may not use any Content in any manner that may infringe any copyright, intellectual property right, proprietary right, or property right of us or any third parties.

4. OWNERSHIP. The Software is licensed, not sold. The foregoing license gives you limited license to use the Software. CWD retains all right, title and interest, including all copyright and intellectual property rights, in and to, the Software and all copies thereof. The structure, organization and code of the Software are the valuable trade secrets and confidential information of CWD. The Software is protected by law, including without limitation the copyright laws of the U.S. and other countries, and by international treaty provisions. Compass Web Design, TileGem and other trademarks contained in the Software are trademarks or registered trademarks of CWD in the United States and/or other countries. Third party trademarks, trade names, product names and logos may be the trademarks or registered trademarks of their respective owners.
